The candidates shall apply online for B.Sc. Nursing course and the Application is available in the website www.nehrunursing.com. All the candidates shall fill all required column including the column for DD (Demand draft) number or Online Transaction details of application fee. The DD for Rs. 1000/- shall be taken in favour of Nehru College of Nursing payable at Ottapalam , or the amount can be transferred to the following bank account.

How to Apply.

Application for admission to B.Sc. Nursing course can be registered only through online in a single application. The provision for applying online is available at the website http://nehrunursing.com/ Prospectus can also be downloaded from the website. However, it will not be available by post. Submission of more than one application form by a candidate will lead to rejection of the candidature.

Application Fee:

- (i) The application fee will be Rs.1000/- for all candidates, payable through DD (Demand draft) or online payment by using Credit/Debit/Internet Banking/ facility. Application submission will be completed only after successful payment of Application fee through online.
- (ii) If the payment is debited and you are not guided to the second stage please inform us to info.nehru@gmail.com with your login details or email-id or mobile number, we will provide you the required help within 24Hrs.
- (iii) Application fee once remitted will not be refunded in any circumstances.

Remittance of Application Fee and Submission of Application Form:

The candidates can get the instruction to make the payment and submission of application form in the link "Admission 2022-2023" on the website http://nehrunursing.com/

Note:

- 1. Online application form will be considered only if the Original DD or the online Payment is submitted at the College office.
- 2. Incomplete or delayed application form will not be accepted.
- 3. The last date for submitting online application is 07th August 2022.
- 4. The last date for submitting the hard copy of application form along with Original DD or the online payment details and certificate copies of SSLC, Plus Two and copy of Aadhar card to the College office on or before 08 August 2022 before 5.00 pm.
- 5. Application form submitted after the above mentioned cut-off date will not be considered by the Colleges.
- 6. The original documents shall be produced at the time of admission.

Preparation of Merit List (Management Quota & NRI Quota)

Merit list:

- (a) Out of 45 seats 32 seats will be filled by management from among the online applications on the basis of merit list prepared, based on the marks obtained in the qualifying examination in the core subjects as mentioned in the eligibility criteria by following the reservation criteria
- (b) Out of 45 seats 13 NRI seats shall be filled up from qualified students as per G.O (MS) No.243/2014/HRFWD dated 6.08.2014 of Govt. of Kerala.
- Resolution of tie while ranking: In the case of a tie in the total marks, the marks in Biology will count. If there is still a tie the marks in Chemistry and Physics will be counted. If a tie till exists, the age of the candidate will be taken into account, the elder will be preferred to the younger.
- Validity of the merit list: The published merit list will be valid till 30-09-2022 or the date up to which the merit list shall be kept alive in terms of instruction/direction of competent authority.
- Inclusion in the merit list will not entitle the applicant eligible for admission to the course, unless the applicant satisfy the rules regarding the eligibility for admission and other conditions as laid down in the Prospectus.
- Furnishing of false information/particulars would result in the forfeiture of the candidature as well as cancellation of admission to the course, and in addition, will attract the relevant provisions of criminal law of the land.

Selection by Allotment Process

- The Allotment Process for Seats in Nehru College of Nursing for which will be made as per the schedule included in the prospectus and allotments will be strictly based on the merit by following the reservation criteria as mention in the prospectus.
- If sufficient candidates are not available in the list of applicants, the vacant seats will be filled up from the eligible candidates as mentioned in the prospectus.

Admission & Payment of Fees

- The selected candidates will be informed through Email/Phone/SMS in to the registered mobile number provided in the application
- The students shall pay all fees of the 1st year of the course at the time of admission which will not be refunded at any circumstances.
- Approved Fee details published in the prospectus
- The entire candidate should pay other fees due to statutory bodies (KUHS, KNMC & INC) as and when notified later by the College / Government.
- Selected Candidates should report for admission on the date as instructed in the Email/Phone/SMS alongwith the following documents
 - Aadhar card or any other identity proof as provided in the application.
 - Mark list of the candidate at the qualifying examination.
 - Pass Certificate of the candidate at the qualifying examination.
 - Document (School Record, SSLC or equivalent) of the candidate to prove his/ her date of birth.
 - Eligibility/equivalency certificate obtained from the Kerala University of Health Sciences by candidates who have passed the qualifying examination from authorities other than the State of Kerala / CBSE / ISCE.
 - A Physical Fitness Certificate in the prescribed format obtained from a Medical Officer in Government Service not below the rank of Assistant Medical Officer.
 - Course and conduct certificate from the institution last attended.
 - Transfer certificate (TC) from the institution last attended.
 - Document/ certificate required in proof of any benefit claimed in the application for reservation.

The candidates selected for NRI quota have to submit the following documents also along with the above documents

- 1. Sponsorship Certificate
- 2. Attested copy of the passport of the sponsor
- 3. The attested copy of the relevant page of the passport where Employment Visa is stamped and if it is not submitted the employment certificate duly attested by the Indian Embassy or consulate.
- 4. *Relationship Certificate from the Village Officer/Tahasildar
- 5. Affidavit
- * Relationship with the sponsor should comply the Government order No. GO(MS) No.193/2013/H&FWD dtd.22.05.2013& KUHS Order No.2836/ACB/KUHS/2014,dated 12.06.2014

Fee Payment Details:

• Selected candidates have to remit all the fees as mentioned above at the time of admission itself. The fee can be paid by RTGS/NEFT/DD/Net banking/Online banking. If all the fee as mentioned above is not remitted within the time of admission, the application of the Candidate will be removed from the admission process.

Discontinuation of Course

• If any candidate discontinues the course, after closing of admission as notified by the authority, the candidate has to pay the full fee of the remaining Course (4 years). The Collection of liquidated damages shall be as per the final decision of the AFRC or Court of Law.
